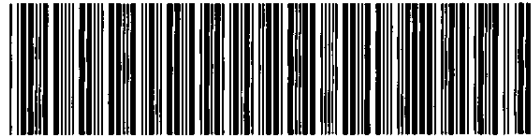


MANAGEMENT
