The undersigned, for the purpose of forming a limited liability company wider the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be WAYNE GILLEY'S TILE SERVICE, LLC ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 5821 Turkey Tree Lane, Plant City, Florida 33567 and the mailing address shall be the same.


