ARTICLES OF ORGANIZATION

MULZT AMII:54

FOR SALAAM PROPERTIES, LLC

The undersigned, under and pursuant to Chapter 608 of the Florida Statutes (the "Act"), for the purpose of forming a limited liability company under the laws of the state of Florida, does set forth the following:

- Name. The name of this company shall be SALAAM PROPERTIES, LLC.
- 2. Duration/Continuation. Unless earlier terminated under the Act or the Operating Agreement, the period of duration of the Company shall be perpetual.
- 3. Purpose. The purpose for which the Company is organized is to engage in any and all business and activities permitted by the Act and any other applicable laws of the State of Florida. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.
- 4. Address of place of business. The mailing address for the company is 805 Virginia Avenue, Suite 16, Fort Pierce, FL 34982 and the street address of the place of business for the Company is 805 Virginia Avenue, Suite 16, Fort Pierce, FL 34982. These addresses may be changed from time to time as provided in the Operating Agreement.
- 5. Registered Agent and Office. The initial registered agent in Florida for the Company is Syed Shafeeq Ur Rahman and the initial registered office is located at 805 Virginia Avenue, Suite 16, Fort Pierce, FL 34982.
- 6. Capital Contributions. Contributions to the capital of the Company shall be made by members, in the manner prescribed by the written Operating Agreement made and entered into by the members, which may be amended from time to time in accordance with its terms.
- 7. Members. The Company shall have at least one member and may admit additional members on the prior unanimous written agreement of the then-existing members, or as otherwise provided in the Operating Agreement.
- On the death, retirement, resignation, Continuity of Business. expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company, or upon any other event that, under the Act, would result in dissolution of the Company, the business of the Company may be continued and the Company will not be dissolved

without the prior written consent of all the remaining members of the Company.

9. This Company will be managed by one or more managers appointed by the members in accordance with the terms of the Operating Agreement. As such, the Company will be manager-managed. The members, at a meeting of the members held not less than annually, shall designate the managers, who may also be members, and the positions that these managers will hold. The initial managers, who shall serve until the first annual meeting of the members or until their successors are elected and qualify, and their designations shall be as follows:

10.Indemnification. Except as expressly provided in the Operating Agreement, the Company shall indemnify any member, manager, or former member or manager to the full extent permitted under the Act.
