**ARTICLES OF ORGANIZATION

The undersigned, who is duly licensed to practice law in the State of Florida, desiring to form a limited liability company in accordance with Chapter 608 of the Florida Statutes, the Florida Limited Liability Company Act, and Chapter 621 of the Florida Statutes, the Professional Services Corporation and the Limited Liability Company Act, adopts the following Articles of Organization:

**ARTICLE I — Name:**


