Name**

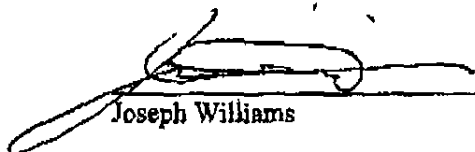
