# ARTICLES OF ORGANIZATION OF

BB II - OUTPARCEL INVESTORS, LLC

Male 2 Philips The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes (the "Florida Limited Liability Company Act"), for the purpose of forming a limited liability company under the laws of the State of Florida does set forth the following:

### 1. **NAME**

The name of the limited liability company is BB II - OUTPARCEL INVESTORS, LLC (hereinafter referred to as the "Company").

### 2. PERIOD OF DURATION

The period of duration of the Company shall be from the date of filing of its Articles of Organization until the first to occur of the following:

- (i) Dissolution of the Company pursuant to the provisions of the Florida Limited Liability Company Act; or
- By the mutual written agreement of a majority in ownership interest of the (ii) members of the Company (each a "Member" and, collectively, the "Members"); or
- (iii) As provided for in a written Operating Agreement executed by all of the Members.

The Company shall have at least one (1) Member, and may admit additional Members upon the prior unanimous written agreement of the then existing Members, or as otherwise provided in the Operating Agreement. The initial Members shall be Michael O. Abdoney and Rebecca Abdoney, husband and wife, as tenants by the entirety. New or additional Members may be added in the manner provide for in the Operating Agreement.

## 7. CONTINUITY OF BUSINESS

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company, the business of the Company shall be continued and the Company shall not be dissolved without the prior written consent of all the remaining Members (if any) of the Company.
