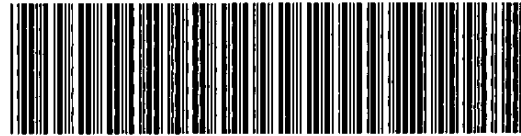



#### ARTICLE VII - Amendments


