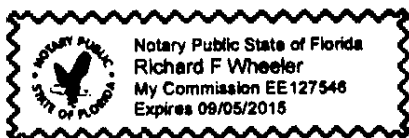
1. The name of the limited liability company is 3000 PEARSON ROAD, LLC.
