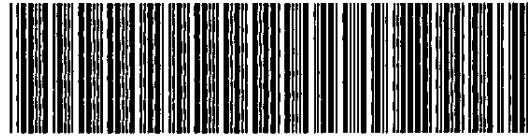

NAME

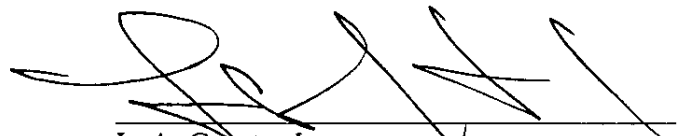
