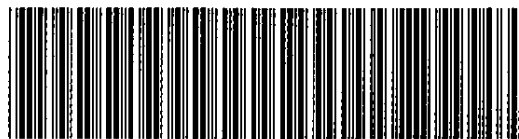

KNOW ALL MEN BY THESE PRESENTS: That we, Eric Hudson & Shebard Germulus, desiring to form a limited liability company for the purposes set forth herein and in conformance with the Florida Limited Liability Company Act, do establish:

1. Company Name: That the name of the limited liability company is Ground Level Exhaust and Customs, Limited Liability Company.
2. Duration: That the period of duration of this limited liability company is thirty years from the date of filing hereof with the Florida, unless sooner dissolved as provided by Florida law.
3. Purpose: That the purpose for which this limited liability company is organized is primarily to any and all legal business, and other goods and services that are permitted by law, within and without the Florida as the laws of Florida and other states permit.
4. Principal Place of Business: That the address of its principal place of business is 6544 E Colonial Drive Orlando, FL 32807
5. Registered Agent and Office: That the name of its registered agent, whose Consent to Appointment as Registered Agent accompanies these articles, is LDL Accountants & Associates CPA, Firm, LLC, and address of the agent at the registered office is 7205 E Curry Ford Road Orlando, FL 32822
6. Capitalization: That the total capital contributions of each Member, which is his or its respective undivided interest in personal property having at least a value totaling 100.00 should be allocated as follows: 50.00 Cash Contribution Eric Hudson and 50.00 Cash Contribution Shebard Germulus.

Eric Hudson and Shebard Germulus of 8450 Valencia Village Lane Apt # 201 Orlando FL 32825 are to serve as Chief Manager and Executive Officer.
7. Additional Liability of Members: That no additional capital contributions will be required.
8. Admission of Additional Members: That additional Members will be admitted or expelled only with the unanimous consent of all Members entitled to participate in management and upon such terms as are unanimously agreed to by all Members entitled to a dividend upon dissolution or liquidation.
9. Continuity of Life: That the remaining Members of the limited liability company may only have the right to continue the business upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or occurrence of any other event which

The return of capital and the distribution of profits shall be determined from the company's books, as of the effective date of withdrawal, based on generally accepted accounting practices, and paid as soon as practicable without diminishing the prospects of the company's ventures and subject to the limitations of the Florida Limited Liability Company Act.

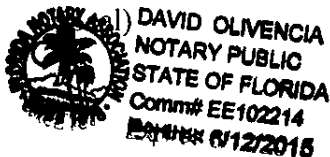


