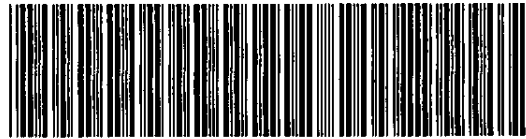

The name of the limited liability company is Oceanmar Park Apartments, LLC (hereinafter, the "Company").


