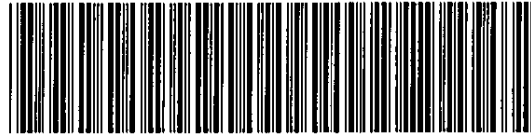

The name of the Limited Liability Company is MB LOAN HOLDINGS, LLC (the "Company").

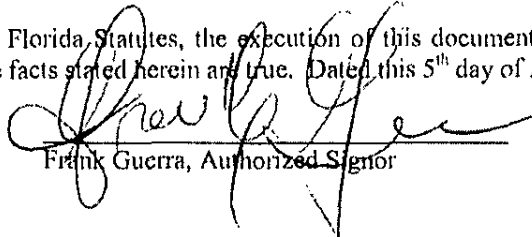

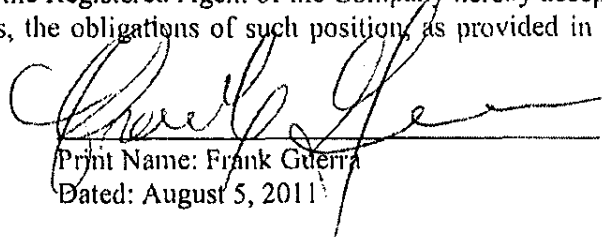
