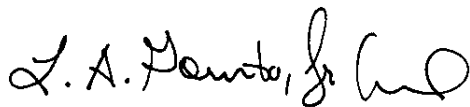

NAME

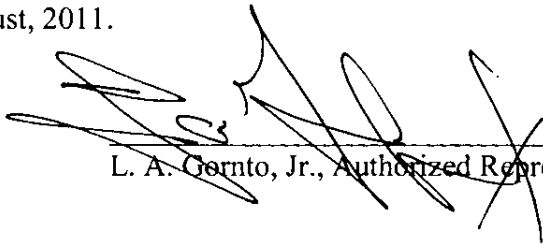

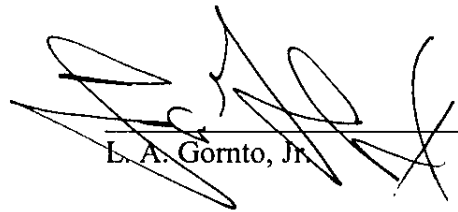
