The name of the Limited Liability Company (hereinafter referred to as "Company") is **PTS, STRICKLAND ROAD, LLC**.

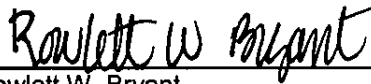
ARTICLE II - PRINCIPAL OFFICE

No Member shall have the authority to incur debt or contractual liability on behalf of the Company solely by virtue of being a Member, except that of the managing Member or managing members.

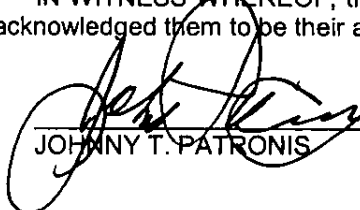
ARTICLE VII - REGULATIONS
