Article IV. Management

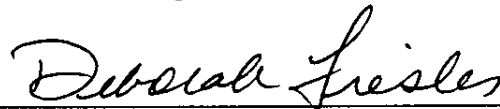

Article V. Limitation on Agency Authority of Members

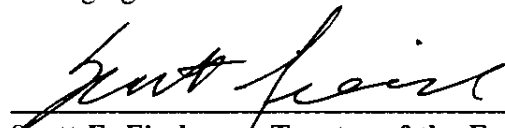

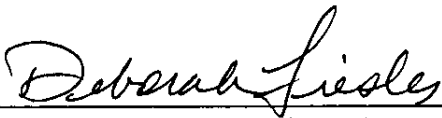
