ARTICLES OF ORGANIZATION

OF

Finest ALF-Brevard, LLC

The undersigned person, acting hereby as Organizer for the purpose of forming a limited liability company under the Florida Statutes, Chapter 608, hereby executes the following Articles of Organization:

- I NAME. The name of the limited liability company shall be: Finest ALF-Brevard, LLC ("Company").
- II ADDRESS. The mailing address of the principal office of the Company shall be 1800 33rd Street, Suite 200, Orlando, Florida 32839-8852. The physical (street) address of the Company shall be 1275 N. Banana River Drive, Merritt Island, FL 32952.
- III DURATION. The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual, unless the Company is dissolved as provided in these Articles of Organization.
