**ARTICLES OF ORGANIZATION
OF
UNDER THE BRIDGE PRODUCTIONS LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, pursuant to Chapter 608 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization (the "Articles").

ARTICLE I. NAME

The name of the limited liability company is **UNDER THE BRIDGE PRODUCTIONS LLC** (the "Company").

ARTICLE II. MAILING AND STREET ADDRESS

The mailing address and street address of the principal office of the Company shall be 4213 Kandra Court, Orlando, Florida 32812, Attention: Keith Alan.

ARTICLE III. REGISTERED AGENT AND OFFICE

The name and street address of the initial registered agent of the Company in the State of Florida is: Keith Alan at 4213 Kandra Court, Orlando, Florida 32812.

ARTICLE IV. DURATION

The Company shall commence its existence on the date that the Articles are filed with the Florida Department of State. The Company's existence shall be perpetual, unless the Company is earlier dissolved as provided in the Operating Agreement.

ARTICLE V. PROFITS AND LOSSES

Profits and losses shall be allocated to the members, as provided in the Operating Agreement, duly adopted and as amended from time to time by the members.

ARTICLE VI. OFFICERS AND MANAGEMENT

The Company shall be a manager-managed limited liability company and shall be managed in accordance with the Operating Agreement adopted by the members for the management of the business and affairs of the Company. The Operating Agreement may contain any provisions for the regulation and management of the business and operations of the Company, not inconsistent with Florida law or the Articles. The initial Managers shall be: Keith Alan and Jason Wald. There Company shall have the office of Treasurer, whose duties shall be as set forth in the Operating Agreement. The initial Treasurer shall be: Stacy Twiggs.

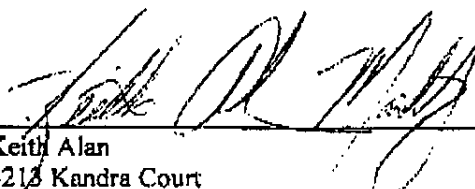

The Articles may be amended only in accordance with the Operating Agreement.

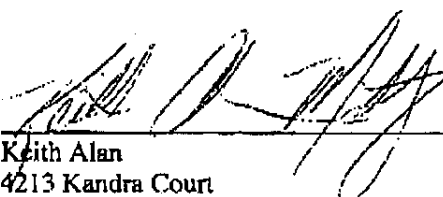
