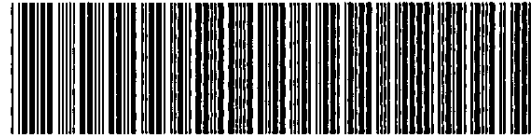

The undersigned, for the purpose of forming a multiple member limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, does hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be **CANAL STREET PROPERTIES LLC** ("Company").

ARTICLE II -- ADDRESS

The street address of the principal office of the company shall be 330 Canal Street, New Smyrna Beach, Florida 32168, and the mailing address is 4514 VanKleeck Drive, New Smyrna Beach, Florida 32169.

ARTICLE III -- DURATION

The company shall commence its existence on the date the articles of organization were filed by the Florida Department of State. The company's existence shall be perpetual.

ARTICLE IV -- REGISTERED OFFICE AND AGENT

ARTICLE V -- CAPITAL CONTRIBUTIONS

These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization. 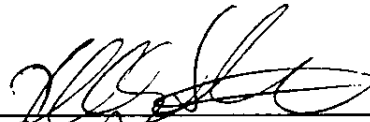
