ARTICLES OF ORGANIZATION OF
URUWAY III, LLC
A FLORIDA LIMITED LIABILITY COMPANY

The undersigned desiring to form a Limited Liability Company under and pursuant to Section 608.404 of the Limited Liability Act, pursuant to Chapter 608 of the Florida Statutes, of the State of Florida, do hereby certify as follows:

SECOND: URUWAY III, LLC shall have a perpetual duration from the date of filing of these Articles of Organization.

THIRD: The purposes for which, URUWAY III, LLC is formed are:
