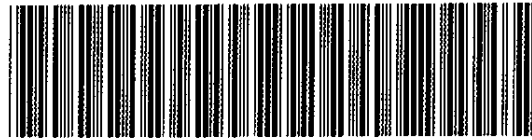

**ADMISSION OF MEMBERS**

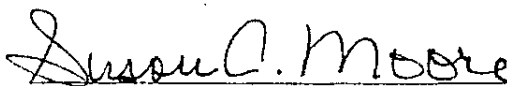
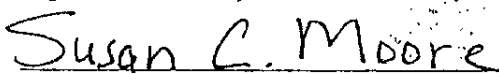
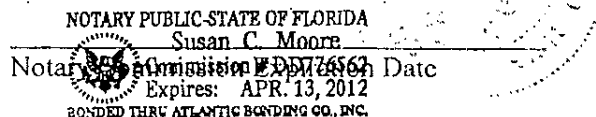
