OF

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes (the "Florida Limited Liability Company Act"), for the purpose of forming a Limited Liability Company under the laws of the State of Florida, do set forth the following:

ARTICLE I: NAME.

ARTICLE X: PURPOSE.

The purpose for which the Company is organized is to act as a holding company for an insurance subsidiary or subsidiaries, and to otherwise engage in any and all other businesses and activities permitted by the laws of the State of Florida. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.
