THE UNDERSIGNED hereby executes and swears to these Articles of Amendment to Articles of Organization of **DR. RICK VENTURE III, LLC**, a Florida limited liability company (the "Company"), pursuant to the Florida Limited Liability Company Act, as amended, *Florida Statutes* § 608.411:

1. Name of Company. The name of the Company is **DR. RICK VENTURE III, LLC**.
