This Limited Liability Company Agreement, made and entered into as of the 23rd day of July, 2015, by the following members of the limited liability company:

In consideration of the mutual covenants herein, the Parties for the limited liability company hereby agree to the following terms and conditions:

Article I

The name of the limited liability company is TEOTWAWKI INVESTMENTS, LLC.

Article II

The principal office of the limited liability company is located at 118 North Pine Avenue Inverness, Florida 34450.

Article III

The business and purpose of the limited liability company shall be to engage in any lawful act or activity in which a limited liability company may engage, including, but not limited to the lawful sale of firearms and firearm equipment. It is and always has been the policy of TEOTWAWKI Investments, LLC to comply with all federal, State, and local laws, including such laws that prohibit unlawful discrimination. However, because the limited liability company is engaged in an inherently dangerous business, the sale and use of firearms, the safety of its customers, its employees, and the community is paramount. Consequently, the limited liability company will not arm, equip, or train anyone it believes to be a threat to public safety. As a Federal Firearms License holder, the limited liability company has that right, and it intends to

exercise that right for the good of public safety. Consistent with this policy, the limited liability company will not serve:

- (a) Anyone who is either directly or indirectly associated with terrorism in any way;
- (b) Anyone associated in any way with an organization that is associated with terrorism;
- (c) Anyone who causes, or seeks to cause, any disturbance whatsoever at the limited liability company;
- (d) Anyone who is not permitted to purchase or possess a firearm under any federal, State, or local law or guideline;
- (e) Anyone who seeks to do harm to the interests of the United States;
- (f) Any person, in the sole judgment of the limited liability company, its owners, managers, and employees, who may pose a threat to public safety based on the person's behavior, comments, history, dress, or other such factors indicating that the person may be a threat to public safety. This judgment will not be based solely upon a person's race, color, religion, or sex.
