Articles of OrganizationofSewMyGosh, LLCA Florida Limited Liability Company

1. Name. The name of this limited liability company is SewMyGosh, LLC (the "Company"), and it shall be formed as a Florida limited liability company under Chapter 608, Florida Statutes.

2. Duration. The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of the State of Florida.

4. Place of Business. The mailing address and street address of the Company's principal office is 3532 SE 18th Avenue, Cape Coral, Florida 33904.

5. Registered Agent and Office. The name of the initial registered agent of the Company is Melissa Sobo. The street address of the initial registered agent of the Company is 3532 SE 18th Avenue, Cape Coral, Florida 33904.



9. Certificated Interests. The members' interests in the Company may be evidenced by certificates.


