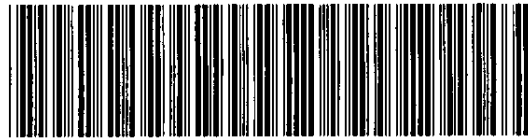

ARTICLES OF ORGANIZATION

1. Name. The name of this limited liability company is **SKYWAY CAPITAL PARTNERS LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.

2. Duration. The Company's existence shall be perpetual.
