ARTICLE I - Name

The name of the Professional Limited Liability Company is **PEREZ EYE CENTER, P.L.**

ARTICLE IV - ADMISSION OF MEMBERS

(a) No person may be admitted as a Member unless such person is a medical doctor licensed to practice medicine in Florida under Chapter 458 of the Florida Statutes, or any successor thereto.

(b) No person may be admitted as a Member, whether as a substituted Member or an additional Member, except upon the approval of all the Members in the manner set forth in the Operating Agreement of the Company, as it may be amended from time to time, or as otherwise agreed by all of the Members.

**ARTICLE V - PHYSICIAN LICENSE SUSPENSION, RESTRICTION OR
TERMINATION**

If a physician Member or physician employee becomes legally disqualified from rendering medical services within the State of Florida or whose medical services become subject to restrictions or limitations as provided in F.S. § 621.10, as it may be amended from time to time or as provided in any successor statute, such physician's employment and financial interest in the Company will be immediately terminated, and such physician will cease to be a Member of the Company and instead will become a creditor only of the Company until the Company's liability for the redemption price of such physician's Interest in the Company as determined in accordance with the Operating Agreement, as amended at the effective time, is satisfied.


