ARTICLES OF ORGANIZATION

OF

Northeast Acupuncture & Oriental Medicine, LLC

The undersigned as the organizer hereby executes and acknowledges the following Articles of Organization for the purpose of forming a limited liability company under the Florida Limited Liability Company Act.

ARTICLE I. NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the limited liability company shall be Northeast Acupuncture & Oriental Medicine, LLC. The mailing address is 2101 16th Street North, St. Petersburg, Florida, 33704. The principal office shall be located at 2101 16th Street North, St. Petersburg, Florida, 33704, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

ARTICLE II. PURPOSES AND POWERS

The purpose for which this limited liability company is organized is to transact any and all lawful business for which limited liability companies may be organized under the laws of the State of Florida including, but not limited to, the following:

1. To engage in any activity or business authorized under the Florida Statutes.
2. In general, to carry on any and all incidental business; to have and exercise all the powers conferred by the laws of the State of Florida, and to do any and all things set forth in these Articles to the same extent as a natural person might or could do.
3. To engage in every aspect of the practice of acupuncture and oriental medicine, and all its fields of specialty.
4. To acquire, own, use, convey, and otherwise dispose of and deal in real or personal property or any interest in such property;
5. To buy, rent, sell, manufacture, produce, assemble, distribute, repair, provide and service any and all products or services in which the company desires to engage;
6. To do such other acts as are incidental to the foregoing or desirable in order to accomplish the purpose for which the company was formed;
7. To have and exercise all rights and powers that are now or may hereafter be granted to limited liability company by law.

The foregoing shall be construed as objects, purposes and powers, and enumeration thereof shall not be held to limit or restrict in any manner the powers hereafter conferred on this limited liability company by the laws of the State of Florida.

ARTICLE III. EXERCISE OF POWERS

All limited liability company powers shall be exercised by or under the authority of, and the business and affairs of this limited liability company shall be managed under the direction of, the members of this limited liability company. This Article may be amended from time to time in the

ARTICLE V. MEMBERSHIP RESTRICTIONS

Members shall have the right to admit new members by unanimous consent. Contributions required of new members shall be determined as of the time of admission to the limited liability company.

The limited liability company shall be dissolved and its affairs wound up, upon the will of the members, or at such time as the limited liability company has no members. Notwithstanding any provision of the Act to the contrary, and except as otherwise provided in the immediately preceding sentence, the limited liability company shall continue and not dissolve as a result of the death, retirement, resignation, expulsion, bankruptcy, or dissolution of any member or any other event that terminates the continued membership of a member.

ARTICLE VI. DURATION

This limited liability company shall exist until dissolved in a manner provided by law, or as provided in the regulations adopted by the members.

ARTICLE VII. INITIAL REGISTERED OFFICE AND REGISTERED AGENT


