**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
SUBARU OF HILTON HEAD, LLC**

The Articles of Organization of Subaru of Hilton Head, LLC, a Florida limited liability company (the "Company"), were filed with the Florida Department of State on August 24, 2011. Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act (the "Act"), the Articles of Organization of the Company are hereby amended and restated in their entirety to read as follows:

ARTICLE I - NAME

The name of the Company is Subaru of Hilton Head, LLC.

ARTICLE II - PRINCIPAL OFFICE

The mailing address and the street address of the principal office of the Company is 265 Drivers Way, Hardeeville, South Carolina 29927.

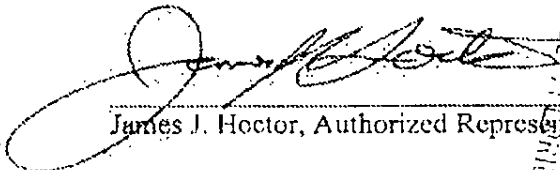
ARTICLE III - REGISTERED OFFICE AND AGENT

The Company is a manager-managed limited liability company and the current manager of the Company is Peacock Automotive Low Country, LLC, a Florida limited liability company.

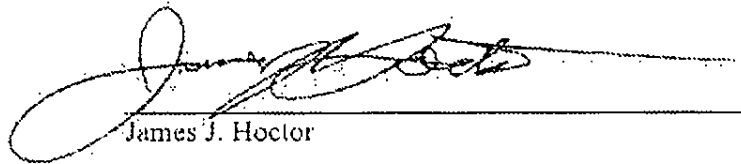
