**ARTICLES OF ORGANIZATION**

I, the undersigned natural person of the age of twenty-one years or more, acting as the organizer of a Limited Liability Company under the General Corporate Laws of the State of Florida, do hereby adopt the following, Articles of Organization:

**FIRST:** The name of the Limited Liability Company is Denese V. Inniss L.L.C.


