# ARTICLES OF ORGANIZATION FILED OF 11 AUG 24 AM 8:08 MICHAEL WEST AGENCY LLCLAHASSEE, FLOREDA

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### **ARTICLE 1 - NAME**

The name of the limited liability company shall be **MICHAEL WEST AGENCY LLC** ("Company").

#### **ARTICLE 2 - ADDRESS**

The principal place of business of the Company in Florida shall be 17146 Avenue Le Rivage, Boca Raton, Florida 33496 and the mailing address shall be the same.
