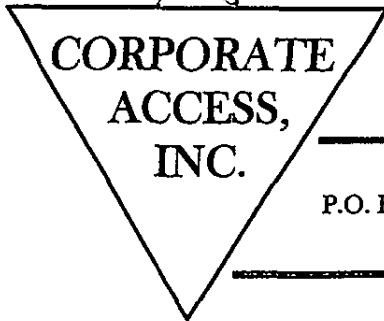

The name of the Registered Agent is **Paul F. Rahill** and whose Florida street address is **932 Versailles Circle, Maitland, Florida 32751**.

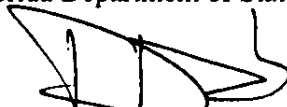
