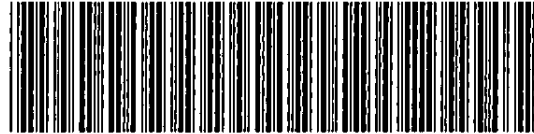

**ARTICLES OF ORGANIZATION
FOR
NASAJON VENETIA, L.L.C.
A FLORIDA LIMITED LIABILITY COMPANY**

ARTICLE I - NAME

The name of the Limited Liability Company is: **NASAJON VENETIA, L.L.C.**

ARTICLE II - DURATION
