ARTICLES OF ORGANIZATION

OF

VANIK INVESTMENTS, LLC

The undersigned certifies that I have associated myself together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. I further declare that the following Articles shall serve as the Charter and authority for the conduct of business of the Limited Liability Company.
