**ARTICLES OF ORGANIZATION  
OF

**ARTICLE I - NAME**

The name of the limited liability company shall be 3821 SE 7<sup>th</sup> AVENUE, LLC (the "Company").

**ARTICLE VI - MANAGEMENT OF THE COMPANY**


