AMENDED AND RESTATED
ARTICLES OF ORGANIZATION FOR
MAP STROBBE ENTERPRISES, LLC

The original Articles of Organization for MAP STROBBE ENTERPRISES, LLC were filed on August 29, 2011, and assigned Florida Document Number L11000099160. Pursuant to the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act, the undersigned Florida limited liability company hereby amends and restates its Articles of Organization in their entirety and adopts the following Amended and Restated Articles of Organization in their place:




