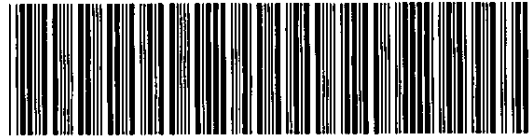

The undersigned hereby submits these Amended and Restated Articles of Organization ("*A/R Articles of Organization*") which amends and restates in the entirety those Articles of Organization filed August 29, 2011 ("*Original Articles of Organization*") of Advanced OPS Solutions, LLC, a Florida limited liability company, and the same is submitted under the Florida Revised Limited Liability Company Act, Chapter 605, *Florida Statutes*, to be made effective as of the date of filing.

**ARTICLE I - Name**

The name of the Florida limited liability company, formed effective as of August 29, 2011, pursuant to the filing of the Original Articles of Organization, is Advanced OPS Solutions, LLC (the "*Company*").

**ARTICLE II - Address**

The mailing and street address of the Company is 15600 NW 15<sup>th</sup> Avenue, Suite C, Miami, Florida 33169.

**ARTICLE III - Duration**

The period of duration for the Company shall be perpetual, unless dissolved by its membership or in accordance with the terms of the operating agreement of the Company then in effect between or among the members.


