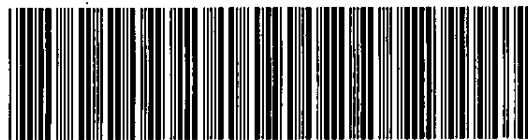

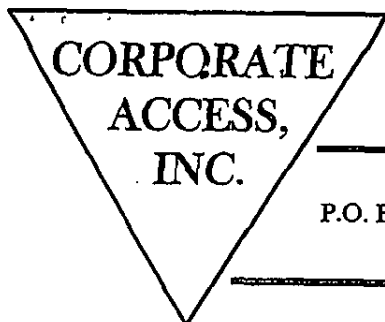

**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
SUNCOAST ENT SURGICAL SPECIALISTS, P.L.**

These Amended and Restated Articles of Organization are filed in accordance with Section 608.411, Florida Statutes, to amend the Articles of Organization of SUNCOAST ENT SURGICAL SPECIALISTS, P.L. (the "Company") initially filed on August 30, 2011 and assigned Florida document number L11000099407. The amendments include changes to the mailing address, principal office address, and address of the registered agent. The Company adopts its Amended and Restated Articles of Organization to operate a professional limited liability company under Chapters 621 and 608, Florida Statutes.

**ARTICLE I.
Name**

The name of the Company shall be Suncoast ENT Surgical Specialists, P.L.

**ARTICLE II.
Duration**

The Company shall exist perpetually.

**ARTICLE III.
Address; Principal Office**

The initial street and mailing address for the Company is 4714 N. Armenia Avenue, Suite 200, Tampa, Florida 33603.

**ARTICLE IV.
Initial Registered Office and Registered Agent**

The address of the initial registered office of the Company is 4714 N. Armenia Avenue, Suite 200, Tampa, Florida 33603, and the name of the initial registered agent at such address is Daniel A. Vincent, Jr., M.D.

**ARTICLE V.
Purpose**

The Company may engage in any activity or business in the practice of medicine permitted under the laws of the United States of America and this state.

ARTICLE VI.
Restriction on Membership

Membership in the Company shall be limited to individuals who are licensed as physicians in the state of Florida under Chapter 458 or 459, Florida Statutes, and entities whose membership is limited to such individuals.

ARTICLE VII.
Management

The Company shall be managed by one or more managers selected in accordance with its Operating Agreement.
