AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF SUNCOAST ENT SURGICAL SPECIALISTS, P.L.

These Amended and Restated Articles of Organization are filed in accordance with Section 608.411, Florida Statutes, to amend the Articles of Organization of SUNCOAST ENT SURGICAL SPECIALISTS, P.L. The amendments include changes to the mailing address, principal office address, and address of the registered agent.
