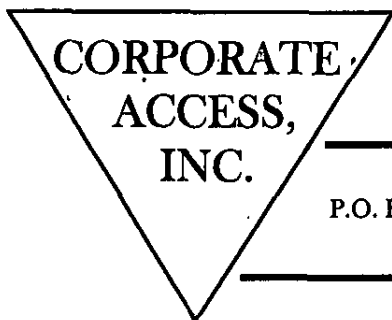

The undersigned hereby certifies that he is a member of The Tampa Bay Hearing & Balance Center, P.L. (the "Company") who files these Articles of Organization to form a professional limited liability company under Chapters 621 and 608, Florida Statutes. The following Articles of Organization are hereby adopted.

**ARTICLE I.  
Name**

The name of the Company shall be The Tampa Bay Hearing & Balance Center, P.L.

**ARTICLE II.  
Duration**

The Company shall exist perpetually.

**ARTICLE III.  
Address; Principal Office**


**ARTICLE VII.


