**ARTICLES OF ORGANIZATION
OF

ARTICLE I - NAME

The street address of the initial registered office of the Company is 6810 Highway 2311, Panama City, FL 32404, and the name of its initial registered agent at such address is John W. Meyer


ARTICLE IV - MANAGEMENT OF THE COMPANY


