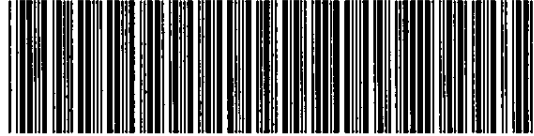

**CHANGE OF REGISTERED AGENT:**

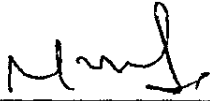

Marisol Vital shall be the new Registered Agent of the Company at 8814 Sleepy Creek Court, Tampa, Florida 33634.

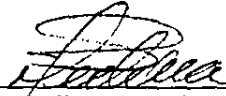
