TO
ARTICLES OF ORGANIZATION
OF

1. The Name of the limited liability company is: Digital Pathways, LLC (the "Company").

2. The date of filing of the Articles of Organization of the Company was September 1, 2011, and assigned document number L11000100714.

3. The Company amends its Articles of Organization by amending Article III to change the mailing and street address of the principal office of the Company to 24711 Harbour View Drive, Ponte Vedra Beach, Florida 32082.
