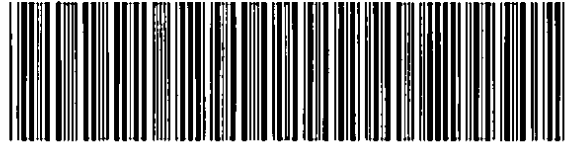

**ARTICLES OF MERGER
OF
FCC BEACH HOTEL, LLC
AND
FCC HOTEL TOWER, LLC**

Pursuant to Section
605.1025

of the Florida Revised Limited Liability Company Act

THESE ARTICLES OF MERGER (these "Articles") are entered into between FCC Beach Hotel, LLC, a Florida limited liability company and result of conversion of FC Beach Hotel, Ltd., a Florida partnership (collectively, the "Merging Party"), and FCC Hotel Tower, LLC, a Florida limited liability company (the "Company").

Under Section 605.1025 of the Florida Revised Limited Liability Company Act ("FRLCA"), the Company and Merging Party hereby adopt the following Articles of Merger:

1. The Agreement and Plan of Merger dated as of December 30, 2021 ("Plan of Merger") by and between the Company and the Merging Party and the Merger (defined below) was approved respective members and managers of each of the Merging Entity and the Company in accordance with the FRLCA.
2. Under the Plan of Merger, the Company will be the surviving company, and the Merging Party will cease to exist (the "Merger"). The Articles of Organization and operating agreement of the Company shall be the Articles of Organization and operating agreement of the surviving corporation.
3. Under the Plan of Merger, the managers and officers of the Company prior to the effective date of the Merger will be the managers and officers of the Merging Party, following the effective date of the Merger, until such time as successors are duly elected or appointed and qualified or until their earlier death, resignation or removal in accordance with the surviving entity's articles of organization, operating agreement and applicable law.
4. The Company has agreed to pay any members of any limited liability company with appraisal rights the amount to which such members are entitled under the provisions of Sections 605.1006 and 605.1061-605.1072 of the FRLCA.
5. The effective date of the Merger shall be the date these Articles are filed with the Department of State of Florida.
