#### SUMI RESTAURANTS, LLC

The Articles of Organization of Sumi Restaurants, LLC (the "Company"), were filed with the Florida Secretary of State on September 1, 2011, and were assigned document number L11000100771. Pursuant to the Florida Limited Liability Company Act, Chap. 608, Florida Statutes, as amended from time to time (the "Act"), the Articles of Organization of the Company are hereby amended and restated in their entirety as follows:

#### **ARTICLE I NAME**

The name of the Company shall be "Sumi Restaurants, LLC".

#### ARTICLE II ADDRESS
