


1. The name of the "Other Business Entity" immediately prior to the filing of this Certificate of Conversion is: Lake Beauty Partnership





Registered Agent, Registered Office and Registered Agent's Signature



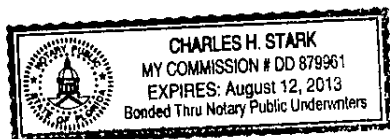
