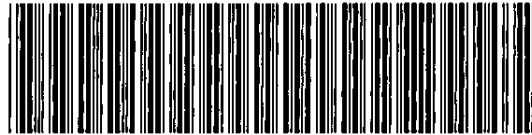

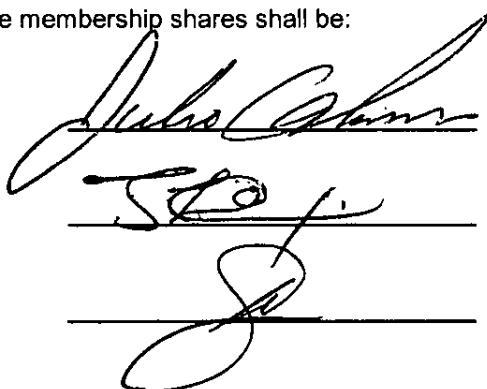

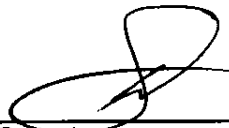
ARTICLE VI : INDEMNIFICATION
