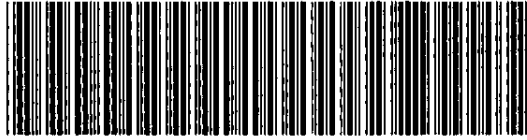

ARTICLES OF ORGANIZATION

of

MergeEHR LLC

The undersigned hereby forms and establishes a limited liability company pursuant to Chapter 608, Florida Statutes, as follows:

ARTICLE I

The name of this limited liability company is MergeEHR LLC (the "Company").

ARTICLE II

ARTICLE III

IN WITNESS WHEREOF, the undersigned authorized representative submitting these Articles of Organization affirms that the facts stated herein are true, and acknowledges awareness that false information submitted in a document to the Florida Department of State constitutes a third degree felony as provided for in Sec. 817.155 of the Florida Statutes, and understands the requirement to file an annual report between January 1st and May 1st in the calendar year following formation of the limited liability company and every year thereafter in order to maintain active status.


