ARTICLES OF ORGANIZATION

OF

BENEFICIAL EQUITY GROUP LLC

The undersigned acting as the organizer of BENEFICIAL EQUITY GROUP LLC under the Florida Limited Liability Company Act, Chapter 608, <u>Fla. Stat.</u>, adopt the following Articles of Organization:

ARTICLE I - Name:
