NAME**

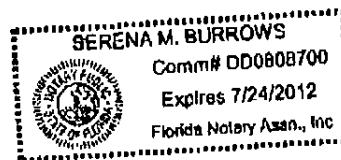



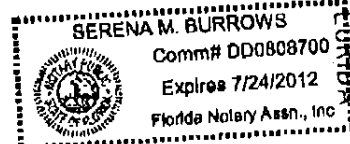
