**ARTICLES OF ORGANIZATION OF
QSBG, LLC**

The undersigned, ROBERT D. HART, JR., a natural person competent to contract and an authorized representative of a member of QSBG, LLC, hereby presents these Articles of Organization as the Articles of Organization of QSBG, LLC, a limited liability company formed under the provisions of Chapter 608, Florida Statutes.

ARTICLE I - NAME

The name of the limited liability company is:

QSBG, LLC

This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The Initial mailing and street address of the principal office of the Company is 913 Gulf Breeze Parkway, Suite 6, Gulf Breeze, Florida 32561.

ARTICLE III - PURPOSES AND POWERS

This Company is organized for the single purpose of owning and selling an airplane that is described as follows: 1980 Sabre Liner 65 Jet, Serial Number 465-004 and FAA Registration Number N804PA. The Company may exercise all powers and rights which a limited liability company may exercise under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, as such chapter exists and may hereafter be amended.

The date for commencement of the Company's existence shall be the date these Articles of Organization are filed with the Florida Department of State. The Company shall have a perpetual existence unless the Company is terminated as provided in its Operating Agreement.


ARTICLE VII - RESTRICTION ON MEMBERSHIP


